- All central air conditioning units must be installed by an HVAC contractor licensed to operate in Rochelle, IL.
- The HVAC contractor must provide manufacturer EER/SEER and cooling capacity information.
- Only central air conditioners with ratings equal to or greater than 13.0 Seasonal Energy Efficiency Ratio and 13.0 Energy Efficiency Ratio qualify for the \$300 incentive.
- The central air conditioning incentive applies only to central air conditioners with cooling capacities of less than 72,000 Btuh (6 tons).
- RMU reserves the right to conduct on-site inspections of all installations prior to granting incentives.
- The applicant must provide proof that the old unit/appliance was properly disposed.
- The applicant certifies a non-programmable thermostat was replaced with a Learning/Remote Management thermostat.
- The incentives are subject to available funds.
- RMU reserves the right to cancel the Residential Incentive Programs at any time.
- The incentive will be applied as a credit to your RMU Bill.
